The field acquired a clearer scientific identity when Norio Taniguchi introduced the term *nanotechnology* in 1974 to describe manufacturing processes involving nanometre-scale precision. This definition established a conceptual foundation that guided subsequent developments in nanoscale science and engineering (Feynman, 1960; Taniguchi, 1983).

A major turning point occurred during the 1980s with the development of high-resolution characterization techniques. The invention of the Scanning Tunneling Microscope (STM), followed by the Atomic Force Microscope (AFM), enabled researchers to visualize and investigate individual atoms and nanoscale surfaces with unprecedented accuracy. These instruments transformed nanotechnology from a largely theoretical concept into an experimentally accessible discipline, providing new opportunities to investigate atomic-scale phenomena in condensed matter physics, surface science, and advanced materials

research (Binnig & Rohrer, 1982; Binnig et al., 1986).

The discovery of new classes of nanomaterials further accelerated the growth of the field.
